Re: Clark County Sanitation District – Rockwell Road Sewer Project

Dear Congressman Barr:

I write this letter to express my whole-hearted support for the Clark County Sanitation District's sewer project on Rockwell Road and, furthermore, to request an appropriation of \$5 million toward this worthwhile project. Since my election in 2018 as the Magistrate for District 5 in Clark County, I have been deeply involved in solving the issue two (2) aging sewer package plants in my district – Yorktowne Mobile Home Estates and the Verna Hills subdivision. Both plants are operated and owned by homeowners' associations and are approximately 50 years old. The plant at Yorktowne is in imminent danger of failing. Such a failure would likely result in an environmental and public health disaster. In my first term as Magistrate, the Clark Fiscal Court created the Sanitation District to resolve this problem and I have served as a Board-member of the Sanitation District since its founding.

Our plan would involve installing a sewer main along Rockwell Road from Yorktowne to the Strodes Creek waste water plant operated by Winchester Municipal Utilities. Apart from the immediate benefit of retiring the Yorktowne package plant, it will also allow for the eventual retirement of the package plant at Verna Hills in a later phase. Finally, the installation of such an extensive sanitary sewer system will greatly enhance the ability of western Clark County to grow and meet the strong demand for affordable housing. Thank you in advance for your consideration of this request. As always, I appreciate your steadfast leadership in the Congress and your continued support for Clark County.
